The management company is PrismaLife AG. This fund is not an UCITS within the meaning of Directive 2009/65/EC.


#### Objectives and investment policy

The objective of the investment policy is to achieve an attractive increase in value (in euros) with limited risks for the investor by implementing the core/satellite portfolio management strategy. This strategy incorporates traditional fixed-income and equity-based securities known as the "core" portion, with a percentage of selected individual securities in the fixed-income and equity-based side of the portfolio known as the "satellite" portion. The core portion represents 80% to 90% of the entire investment. It consists of funds which are invested in blue-chip shares, of mixed funds or hedged fund types. The satellite portion invests in funds that cover smaller niches, such as US, Asian or European small- and mid-cap securities, emerging markets, commodities, technology, etc. In phases when investment in equity markets may be associated with above-average risks, 100% of the strategy may be invested in money market funds. In addition, the use of derivatives is possible.

The net asset value is calculated daily. Investors can redeem their fund units to PrismaLife AG on any Liechtenstein banking day.

Income received from the investments in the fund is reinvested, as a result of which the value of the units increases,

Investors can accept temporary fluctuations in the net asset value and are not reliant on realising the investment on a certain date.



#### What does this indicator mean and what are its limits?

#### Why is the fund in this specific category?

Strategie Short Term Stability is placed in **Category 4** because its unit price has in the past been subject to moderate fluctuations and therefore both loss risks and profit opportunities may be moderate.

#### The following risks are material to the fund and cannot be adequately captured by the risk indicator:

**Liquidity risks:** Negative market conditions may reduce the ability to sell assets when necessary. This can have a negative impact on the market value of the assets.

**Credit risks:** The fund may invest part of its assets in government and corporate bonds. The issuers of these bonds may become insolvent, resulting in the loss of all or part of the value of the bonds.

**Operational risks:** Human or technical failure, within and/or outside the depositary, but also other events, such as natural disasters, may cause losses to the fund.



#### Charges


